Should I adoption a pet from Reese's Rescues, I agree to the following terms and provisions:

- Should it be necessary, I will allow a home evaluation and provide veterinary reference.
- I will provide the dog/cat with humane care and maintenance in accordance with all current and future state/county and local laws where I reside.
- I will provide the dog/cat with the necessary veterinary care upon sickness, disease and injury. I will take him/her to the veterinarian annually for examination and routine vaccinations/tests or more often if necessary.
- I agree to provide - at a minimum - the following vaccinations and tests at the intervals required by law or advised by my veterinarian: Rabies (canine and feline), Distemper (canine and feline), Parvo (canine), fecal test (canine and feline), and heartworm test (canine). I also agree to administer a regular course of heartworm preventative.
- I will provide canines with a fully fenced yard or other humane means of exercise. He/she shall not be kept constantly tied or chained outside.
- I will agree to keep all felines **INDOOR** only.
- **If, for any reason, I cannot keep this pet, I shall return it to Reese's Rescues. The pet shall not be given away, sold or exchanged, without prior written consent of Reese's Rescues.**
- This dog/cat will reside in my home, will be kept as a household pet, and will not be used for breeding or exclusively as a hunting or guard dog.
- I agree, from the date of this contract, to release and indemnify Reese's Rescues from any and all claims, known or unknown, now or hereafter arising in connection with this dog/cat.
- I agree to the examination of this dog/cat by Reese's Rescues, at any time and acknowledge that Reese's Rescues has the right to reclaim this pet at any time for failure to comply with the terms of this contract or for the misrepresentations of fact I made on this adoption contract.
- I agree to pay Reese's Rescues, for any and all expenses, including court costs and reasonable attorney's fees, in enforcing the terms and provisions of this contract.
